AMENDMENT TO RESTRICTIVE COVENANTS

THIS AMENDMENT TO RESTRICTIVE COVENANTS made and entered to this 12<sup>th</sup> day of January 2006, by and between Tarheel Land Company (Tarheel), Anderson Homes, Inc. (Anderson) and Michael Mues and wife Reaba Mues (Mues).

WITNESSETH

THAT WHEREAS Tarheel is the developer of Haw Village Subdivision and as such recorded a Declaration of Covenants, Conditions and Restrictions for Haw Village Subdivision (the Covenants) in Deed Book 2215 at Pages 884 through 903 in the Office of the Register of Deeds of Alamance County, N.C. and now desires to amend the Covenants, and

WHEREAS the parties hereto are the owners of all of the lots in Haw Village Subdivision and all parties have agreed to such amendment as evidenced by their signatures hereto,

NOW THEREFORE, in consideration of the premises and other good and valuable considerations moving between the parties it is agreed:

Article VIII Section 4 of the Covenants, entitled "Animals" is hereby deleted in its entirety and the following new section is substituted therefor:

"Section 4 Animals. No animals, livestock or poultry of any kind shall be kept or maintained on any Lot or in any dwelling except that reasonable numbers of dogs, cats, pet birds or other household pets may be kept or maintained, provided that they are not kept or maintained for commercial purposes. All pets must be kept under the direct

control of the owner by fence, leash or harness and may not run freely at any time. Pet owners are required to clean up after their dog or cat when in the Common Areas.”

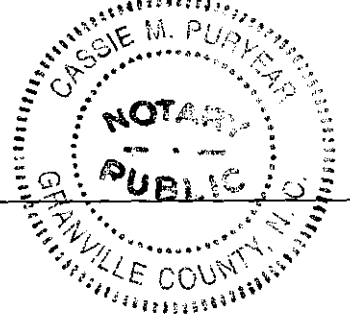

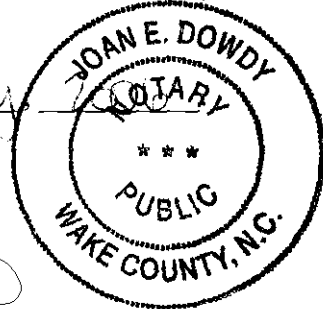
